**Background:**

In our efforts to provide the user, specific information for the products they use, certain changes have been made in the CoQ and Product Package Label of **mdi** Multilayered products with catalog numbers as mentioned above.

**Need for Change:**

**mdi** Multilayered products contain membranes of different pore size rating but it is not being reflected in current CoQ and Product Package Label. The current CoQ and Product Package Label reflects only the pore size rating of the final downstream membrane. Although, the product catalog number mentioned on CoQ and Product Package Label defines the pore size rating of different membranes used, but the understanding of the same to the user is sometime difficult. To make it convenient to understand, CoQ and Product Package Label of **mdi** Multilayered products with catalog numbers as mentioned above have been updated.

**mdi** Multilayered products with catalog numbers as mentioned above, manufactured after the implementation date (**August 05, 2017**) will have the said changes. However, the available stock of **mdi** Multilayered products without pore size rating of different membranes on CoQ and Product Package Label will be received by you till the stocks last.
