Background:

In our efforts to update the user/customer regarding product performance related information, the specification for number of sterilization cycles for **mdi** pre-filter filters type ClariPro GK and ClariSure GK with catalog numbers as mentioned above has been changed based on our recent testings and validations. The specification for number of sterilization cycles (autoclave cycles for ClariPro GK and Steam-in-place cycles for ClariSure GK) has been upgraded from 05 to 25.

Need for Change:

mdi is manufacturing above mentioned products since long time. Based on the validation studies performed, it has been concluded that the number of 30 minutes sterilization cycles at specified temperature that **mdi** pre-filters type ClariPro GK and ClariSure GK can withstand has always been more than 25. Hence, the specification for number of sterilization cycles for **mdi** pre-filters with catalog numbers as mentioned above has been changed from 05 to 25. No change has been done in any critical dimensions or materials of construction or manufacturing process.

The related product literature such as certificate of quality, validation guide, product data sheet, product insert etc will reflect the said changes

How Does It Affect the User:

From a practical point of view this change allows the use of product for more numbers of sterilization cycles. All other product specifications including materials of construction as well as other performance specifications remain unchanged. The accompanying product literature e.g. Certificate of quality, validation guide, product insert etc. will reflect the said change.
