Subject: Change in the Certificate of Quality and Serial Numbering System used in moli Single Use Assemblies/Systems.

This change notice does not apply to the Single Use Assemblies/Systems in which sterilizing grade filters are used.

Scope: This change notification will affect the products with following catalog numbers: (X can be any alphabet or numeral):

- **Background:** The current practice includes labeling of **mdi** Single Use Assemblies/Systems with individual serial numbers. A certificate of quality for each assembly/system is also provided. However, only one Certificate of Quality per lot is provided for the Aseptiliner family and AseptiBag Gold assemblies.

The serial numbering is not required for all single use assembly/system. It is only required for single use assembly/system in which sterilizing grade filters are used.

- **Need for Change:** Serial numbering is necessary in assemblies with serial numbered sterilizing grade filters to ensure traceability. Due to oversight, same practice is followed in assemblies in which sterilizing filters are not used. This results in printing of certificate of quality for each and every type of assembly/system. This is an overdoing/excessive activity that adds no value to quality of the product and requires lot of paper which is not environment friendly. To rectify the problem, the following changes are proposed:
 - Serial numbering shall only be allotted to Single Use Assemblies/Systems with sterilizing grade filter. No serial numbering will be allotted to other single use assembly/system in which filters are not used.
 - Only one Certificate of Quality (CoQ) for the respective lot of single use assemblies/ systems shall be provided with the shipment. However, CoQ will be available on the website for ready reference.
 - Individual CoQ's of all sterilizing grade filters in the lot of single use assembly/system shall be provided separately as a bunch with the shipment.
 - All CoQ's shall be put in one of the packaging boxes with label "Certificate of Quality Inside" pasted on two sides of the box.

No change has been done in any performance specification, product attribute, material of construction and manufacturing process of **mdi** Single Use Assemblies/Systems.
