Background:

This change notice has been initiated to notify for the changes made in the Certificate of Quality (CoQ) of AspetiLiner. The following changes shall be made in product related literature.

- 1. Revision of endotoxin level specification
- 2. Addition of Revision No.

The change will have no impact whatsoever on the product performance or it's regulatory compliance.

Need for Change:

mdi Single Use Assemblies and AseptiLiner are validated for Endotoxin level as per USP <85> Bacterial Endotoxin and the specification for the same is 0.25 EU/ml. However, the specification for AseptiLiner mentioned in product literature (Certificate of Quality, validation guide and data sheet etc.) is 0.125 EU/ml. Therefore, to harmonize the Endotoxin level specification for AseptiLiner, the same shall be revised from 0.125 EU/mL to 0.25 EU/mL in product literature.

Also, the customers/users require information regarding revision number of the drawing for better traceability. In order to communicate the revision no. to the customer/user in a better way the same shall be added in the certificate of quality.

All product specifications including materials of construction as well as other performance specifications shall remain unchanged.

How Does It Affect the User:

From the user point of view, this is only a document change in terms addition of revision no. and change in specification. All product specifications including materials of construction as well as other performance specifications shall remain unchanged. The said changes will be reflected in the accompanying product literature.
