Background:

This change notification is initiated to notify our customers regarding the new **mdi** gamma irradiation facility which shall be used for sterilization of **mdi** products with catalog numbers as mentioned above. This facility shall be used in addition to existing service providers qualified and used by **mdi** for gamma irradiation of different products.

The change will have no impact whatsoever on the product performance or the regulatory compliance.

Need for Change:

Currently, **mdi** products with catalog numbers as mentioned in the scope are irradiated from outsourced gamma irradiation service providers. These service providers are qualified through audit.

The demand for gamma sterile products is continuously increasing and it is sometimes not possible to get the irradiation done timely from existing service providers. This results in delays in product delivery and increases the product lead time.

In order to serve customer better and to reduce lead times, a new **mdi** gamma irradiation facility has been setup. This facility will serve in addition to the existing service providers.
