Background:

The mdi address printed on primary packaging (Tyvek) of these products shall be changed from 20 - 21, Industrial area, Ambala Cantt – 133 006 (Corporate site address) to Advanced Microdevices Pvt. Ltd. Jawahargarh Road, Village - Tepla, Ambala (Manufacturing site address).

The change will have no impact whatsoever on the product performance or it's regulatory compliance.

The address of above manufacturing site is mentioned in all product related technical and commercial documents. However, currently the address of corporate site is printed on primary packaging (Tyvek) of these products. This sometimes makes it difficult for the customer/user to trace the manufacturing site through the package of **mdi** Stericheck and Dilutor. Hence, to improve the traceability, it has been decided to mention the address of the manufacturing site (as mentioned above) on primary packaging (Tyvek) of **mdi** Stericheck and Dilutor instead of corporate site address.

No change has been made to the manufacturing site and only the address printed on primary packaging (Tyvek) of **mdi** Stericheck and Dilutor shall be corrected.

How Does It Affect the User:

From a practical point of view, this change will provide the correct information regarding the product manufacturing site and eliminate the chances of confusion regarding the manufacturing site of **mdi** Stericheck and Dilutor. All performance specifications, product attributes, materials of construction (MOC) and product related literature shall remain unchanged.

However, the available stock of **mdi** Stericheck and Dilutor with catalog numbers as mentioned in the scope, having corporate site address printed on primary packaging (Tyvek), will be supplied until the stocks last.
