Subject : **Change in Lot numbering system of mdi Pre-sterilized Membrane Disc Filters (All types)**

Scope : **This change notification will affect the following products:**

- **mdi** Pre-sterilized Membrane Disc Filters Type RGCN-S (all pore sizes)
- **mdi** Pre-sterilized Membrane Disc Filters Type CN-S (all pore sizes)
- **mdi** Pre-sterilized Membrane Disc Filters Type EHCN-S (all pore sizes)
- **mdi** Pre-sterilized Membrane Disc Filters Type NN-S (all pore sizes)
- **mdi** Pre-sterilized Membrane Disc Filters Type HNN-S (all pore sizes)
- **mdi** Pre-sterilized Membrane Disc Filters Type PL-S (all pore sizes)
- **mdi** Pre-sterilized Membrane Disc Filters Type HVF-S (all pore sizes)
- **mdi** Pre-sterilized Membrane Disc Filters Type GMCN-S (all pore sizes)

Background:

In our efforts to rationalize production process/steps, certain changes have been made in the lot numbering system of **mdi** Pre-sterilized Membrane Disc Filters (All types).

Need for Change:




How Does It Affect the User:

From a practical point of view, this change only affects the lot numbering system printed on product label as well as packaging label. All performance specifications, product attributes, product packaging and traceability remain unchanged.

- Seven digit lot number which includes three digit sterilization cycle number has been changed to four digit lot number and a separate three digit sterilization cycle number (Ster. No.) for convenience and better traceability. Product label and product packaging label will change accordingly (Table – 1).
- Three digits sterilization cycle number (Ster. No.) printed on Product label and product packaging label as a part of lot number has been removed as sterilization of the product is being done after printing of product label and it leads to situations where it becomes difficult to maintain the same sterilization cycle number in actual process as mentioned in product label. The product packaging label including sterilization cycle number will remain unchanged for traceability.
