These unique lot and identification numbers are laser etched on each filter device and also printed on the labels of the box in which individual filter is packed.











## **Typical Water Flow Rates**


### 0.1μm *BioPro®KS*-γ, Large Capsule Filter






### 0.2µm BioPro®KS-γ, Large Capsule Filter
